



## Te Mata School Swimming Pool

**This is an unsupervised pool and the key holder, as signatory to this agreement, must take full responsibility for all the pool users under their charge and comply with the following Terms and Conditions.**

### Price of Keys

\$60 key hire + \$60 bond (refundable upon key return)

### Pool Hours

**9.00am - 7.00pm** Weekends and holidays

**3.00pm - 7.00pm** School days

### Terms and Conditions for Pool Season 2018/2019

1. Opening and closing dates will be determined by the Board of Trustees.
2. Use of the pool is available to all Te Mata School families and wider Te Mata Community or at the Board's discretion.
3. Key holders are to name the users of the key.
4. If Key holders have guests using the pool then the Key Holders must be present at all times and there are to be no more than 4 guests. **Each guest of the Key holder is required to pay \$7.00 per person, into the Koha box or via internet banking into the school bank account.**
5. The pool may be used between the hours of 9.00am to 7.00 pm weekends and holidays, and from 3.00pm to 7.00 pm on school days.
6. Keys will be issued from the school office on payment of a season fee, the signing of a contract by an adult (The Key Holder) and after attending a Health & Safety briefing in person at the school. The dates for these are scheduled for Tuesday 4<sup>th</sup> December 2018 at 3.30pm and Thursday 13<sup>th</sup> December 2018 at 5.00pm.
7. **The keys are non-transferable and remain the property of Te Mata School. They must be returned at the end of Term 1 in 2019, to be eligible for a key the following season.**
8. The pool will be tested regularly. We expect key-holders to co-operate and assist in the management of the pool area generally by keeping it clean and tidy.

9. Please ensure you take all your rubbish with you when you leave.
10. Children must be supervised at all times by an adult who is a key holder.
11. No persons 18 years or under permitted without adult supervision.
12. The rules displayed in the pool enclosure are to be adhered to at all times.
13. Authority to evict any person and/or confiscate keys because of unacceptable behaviour, is given to school staff and Board of Trustee members. The Board of Trustees and supervisors reserve the right to restrict entry and have the right of refusal to issue keys to families who have previously breached the use of pool policy.
14. The staff and Board of Trustees will accept no responsibility for accidents that occur.
15. In consideration of other pool users please no parties to be held regardless of key holder ratios, any queries regarding this issue please contact a Board of Trustees member.
16. Respect must be shown at all times for fellow pool users, failure to do so will result in confiscation of keys.

## **Pool Safety Rules**

### 1. At all times

**NO** running around pool area.

**NO** diving or bombs in pool.

**NO** food or drink in pool.

**NO** persons 18 years or under permitted without adult supervision.

**NO** behaviour which is unsafe or annoying to others.

**NO** animals and no bicycles, skateboards scooters, skates to be ridden in pool area.

**NO** alcohol/smoking in the pool area, or on the school grounds at all times.

**NO** barbecues in the pool enclosure.

**NO** parties.

2. Lock gate as you enter or leave. Pool gate remains **closed at all times**.

3. Keys must be produced for inspection if requested.

4. Proper swimming attire must be worn. **Non toilet-trained children must wear leak protection swimming pants.**

**The Staff and Board of Trustees of Te Mata School will accept no responsibility for accidents that occur.**
